These materials consist of a document with readings on main and less mainstream methodological approaches to research in EU and international law, and a series of questions and exercises which encourage reflection on those readings, both in their own terms and in terms of different research agendas. There are also supporting materials, giving guidance on practical matters, such as how to give a paper or be a discussant at an academic conference. The book will help scholars in EU and international law reflect on their research: where does it fit within the discipline, what kinds of research questions do they think are interesting, what theoretical perspective best supports their way of thinking about their project, and so on. The book is aimed at students and more established scholars who are interested in reflecting on the development of their discipline or who are supervising research projects.
