The 1982 Convention on the Law of the Sea, the overarching governance framework for the world's oceans, has been signed and ratified by 156 countries and the European Community, but not by the United States. The balance of power is now shifting in Washington, making prospects for U.S. Senate consent to the convention in 2009 more likely than ever.
